Qualifications for Office

**Are you holding an office which may conflict, or be incompatible, with the office for which you are filing?
Or, is your employment incompatible with the office you are seeking?**

ALL COUNTY OFFICES, INCLUDING DISTRICT ATTORNEY

No person except a qualified elector shall be elected or appointed to any civil or military office in the state. (Wyo. Constitution, Art. 6, Sec. 15)

COUNTY ASSESSOR

In addition to being a qualified elector, the county assessor shall own real property in the county in which he is elected. (W.S. 18-3-201)

COUNTY ATTORNEY

In addition to being a qualified elector, the county attorney shall be a member of the bar of Wyoming. (W.S. 18-3-301)

DISTRICT ATTORNEY

In addition to being a qualified elector, the district attorney shall be a licensed attorney for at least four (4) years and a member in good standing of the Wyoming state bar immediately prior to his election. (W.S. 9-1-802)
