

RESOLUTION #2014-13

REGARDING THE VACATION OF COUNTY ROADS

WHEREAS, the Board of County Commissioners of Platte County, Wyoming, may by their own motion by resolution duly adopted, where it deems the public interest so requires, initiate the procedure for the vacation or alteration of county highways and roads under the authority of Wyoming Statute §24-3-101, 2009, as amended; and

WHEREAS, the Board of County Commissioners of Platte County, Wyoming, received a request to vacate a portion of Highline Road from a Converse County resident who owns property along the road; and

WHEREAS, the Board of County Commissioners of Platte County, Wyoming, have entered into an agreement with the landowner to cover the costs associated with the proposed vacation of the county roads; and

WHEREAS, the roads being considered for vacation are unmaintained and unused roads; and


WHEREAS, the Board of County Commissioners of Platte County, Wyoming, hereby deem those county roads described on the attached Exhibit A be vacated as required by the public's interest.

NOW THEREFORE, BE IT RESOLVED, that those roads shall be considered for vacation along and across the lands located in Platte County, Wyoming, described on the attached Exhibit A.

IT IS FURTHER ORDERED that this Resolution shall be filed in the Office of the County Clerk, notice of proposed vacation be published and mailed to landowners and all parties having an interest in the lands, and a date for hearing set.

EXHIBIT A

The point of commencement, the course and the point of termination of each road to be vacated are described as follows:

Description #1: a portion of County Road #160 to be vacated: beginning at the northeast corner of Section 17, Township 30N, Range 67W, and running thence due west on the section line one mile to the northwest corner of Section 17;

Description #2: a portion of County Road #229 to be vacated: beginning at the southwest corner of Section 8, Township 30N, Range 67W, thence N01°00'E on section line 1025 feet; thence N73°45'E 740.0 feet; thence N81°15'E 570.0 feet; thence N11°00'W 310.0 feet; thence N71°00'E 850.0 feet; thence N42°45'E 4840.0 feet to northeast corner of Section 8, Township 30N, Range 67W; thence S87°00'E on section line 2480.0 feet; thence S30°00'E 5425.0 feet; thence S7°00'E 530.0 feet.

Description #3: a portion of County Road #157 to be vacated: commencing at the southeast corner of Section 21, Township 30N, Range 67W and running thence north 3 miles to the northeast corner of Section 9 and west one more mile to the northwest corner of Section 9. Said roadway is 60 feet wide.

Description #4: a portion of County Road commencing at the southwest corner of Section 21: beginning at the southwest corner of Section 21; thence north along the section line to the southwest corner of Section 9; thence N78°00'E 205.3 feet; thence N43°45'E 476.0 feet; thence N02°45'W 574.7 feet; thence N54°30'W 596.0 feet; thence due north on section line 4053.0 feet to the northwest corner Section 9; thence north on section line 3517.4 feet; thence N38°30'W 422.7 feet; thence N25°15'E 636 feet; thence due north on section line 549.7 feet to the northwest corner Section 4, Township 30N, Range 67W; said corner is on the Niobrara County line. Said roadway vacation is 60 feet wide.
