RESOLUTION NO. #2016 - 6

A RESOLUTION CONCERNING THE APPROVAL AND CONFIRMATION OF THE DIVISION OF PLATTE COUNTY RURAL FIRE DISTRICT 2F AND ESTABLISHMENT OF ANTELOPE GAP RURAL FIRE DISTRICT PURSUANT TO W.S. § 35-9-212 – § 35-9-215; AND RATIFICATION OF ALL PREVIOUS ACTION TAKEN BY THE BOARD OF COUNTY COMMISSIONERS OF PLATTE COUNTY WYOMING IN CONNECTION THEREWITH.

WHEREAS, the Board of County Commissioners of Platte County, Wyoming ("Board of Commissioners") is authorized under W.S. § 35-9-212 – § 35-9215 to grant and allow a petition for division of a fire protection district; and

WHEREAS, on January 11, 2015 landowner representatives filed a petition for division of Platte County Rural Fire District 2F ("2F District") and Establishment of Antelope Gap Rural Fire District (Antelope Gap District") in accordance with W.S. § 35-9-213 (the "Petition"); a copy of the Petition is marked Exhibit "A" attached hereto and incorporated herein; and

WHEREAS, on April 27, 2015, in accordance with W.S. § 35-9-214, the Board of Commissioners deemed that 2F District and Antelope Gap District have in place sufficient procedures that ensure both Districts have the ability to provide fire protection services to the satisfaction of the Commissioners, that the proposed boundary changes are in the best interests of the public, and that the mutual agreement entered into between 2F District and Antelope Gap District pursuant to W.S. § 35-9-315 is acceptable to the Commissioners; copies of minutes of the regular meetings of the Board of Commissioners dated April 7, 2015 and April 21, 2015 are marked Exhibit "B" attached hereto and incorporated herein; and

WHEREAS, on April 27, 2015, the Board of Commissioners granted and allowed the Petition and appointed members to the newly established board of the Antelope Gap District; and

WHEREAS, there has been presented to the Board of Commissioners a map and legal description depicting the boundaries of 2F District prior to its division and establishment of Antelope Gap District, the same being marked Exhibit "C" attached hereto and incorporated herein; and

WHEREAS, there has been presented to the Board of Commissioners a map and legal description depicting the boundaries of 2F District and boundaries of the newly established Antelope Gap District as a result of the division of 2F District, the same being marked as Exhibit "D" attached hereto and incorporated herein; and

WHEREAS, the Board of Commissioners desires to approve the forms of the aforementioned documents, maps and legal descriptions depicting the boundaries of 2F District and boundaries of the newly established Antelope Gap District as a result of the division of 2F

District, and desires to ratify and confirm all previous action taken by the Board of Commissioners in furtherance of the division of 2F District and establishment of Antelope Gap District.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PLATTE COUNTY WYOMING, THAT:

The Board of Commissioners hereby finds and determines that pursuant to W.S. § 35-9-212 – § 35-9-215, the division of 2F District and establishment of Antelope Gap District having been approved and allowed by the Commission on April 27, 2015 is in the best interest of the public and in furtherance of the purposes of said Districts in providing rural fire protection for the citizens of Platte County Wyoming.

All actions heretofore taken (not inconsistent with the provisions of this Resolution and attachments) by the Board of Commissioners directed toward the division of 2F District and the establishment of Antelope Gap District are hereby ratified, approved and confirmed.



Petition for Division of Platte County Rural Fire District 2F

This special district is to be divided under the authority granted by Wyoming Statutes § 35-9-212 through 35-9-215 pertaining to the division of a fire district and under the Special District Elections Act of 1994, Wyoming Statutes § 22-29-101 through 601.

- 1. That the signatures of owners of fifty percent (50%) or more of the privately owned lands of the proposed detracted area (Antelope Gap Rural Fire Protection District), who constitute fifty percent (50%) or more of the taxpayers within the proposed detracted area are attached to this petition for division.
- 2. The name of the proposed district is Antelope Gap Rural Fire Protection District.
- 3. All land in the Platte County Rural Fire District 2F and in the proposed Antelope Gap Rural Fire Protection District lie within the boundaries of Platte County, WY.
- 4. Description of the boundaries of the proposed Antelope Gap Rural Fire Protection District and the land situated therein with particularity:

That portion on the east side of Platte County Rural Fire District 2F shown in the 2F bylaws as "Antelope Gap Zone" and consisting of those parts of Voting Precinct 1-6 and 9-1 currently in District 2F; excluding Fire District 1F, Guernsey Fire District, Chugwater Fire District, and the areas within the incorporated boundaries of municipalities within the County specifically including Chugwater, Wheatland, Glendo, Guernsey, and Hartville. (See Attachments A and B.)

5. That the persons signing this petition request that the Platte County Rural Fire District 2F be divided under Wyoming Statue § 35-9-212 through 35-9-215, and under the Special District Elections Act of 1994, as amended, Wyoming Statutes § 22-29-101 through 601.

Benefits of forming our own district:

Forming Antelope Gap Rural Fire Protection District would provide for local control, which would benefit landowners and volunteer firefighters. These benefits include:

- 1. Fostering local involvement and "ownership" by residents and landowners.
- 2. Providing funding for equipment and services that better meet the needs of Antelope Gap's firefighters.
- 3. Adoption of fiscal procedures that are flexible and allow firefighters to purchase needed equipment and services in a timely manner.
- 4. Allowing Antelope Gap's assets to earn money by providing aid to other districts on paid fires.

- 5. Helping to minimize Antelope Gap firefighter liability with policies and operating procedures tailored to our district's specific needs.
- 6. Providing fire training that is relevant to Antelope Gap's firefighters and that is appropriate to our grassland habitat.
- 7. Creating a smaller area that is more easily managed by the district board. This would:
 - a) streamline the administrative process,
 - b) make it easier to comply fully with state statute, and
 - c) provide better accountability of public funds.


