

RESOLUTION #2017-10

A RESOLUTION ALLOWING TRAVEL TRAILER CAMPING IN AGRICULTURE ZONING DISTRICTS FROM AUGUST 19, 2017 TO AUGUST 22, 2017

WHEREAS travel trailer is defined by the Platte County Zoning Rules and Regulations as, "A vehicle used and so constructed as to permit its being used as a conveyance upon the public streets or highways and duly licensable as such and which is constructed in such a manner that temporary facilities for dwelling or sleeping are provided upon the frame or bed of such vehicle. Such facilities may be either permanently or temporarily attached," and;

WHEREAS travel trailer camping is currently not permitted within Agriculture zoning districts according to the Platte County Zoning Rules and Regulations, and;

WHEREAS it is anticipated there will be a temporary migratory influx of people to the Platte County Wyoming area during the total eclipse on August 21, 2017, and;

WHEREAS it is the desire of Platte County to temporarily allow travel trailer camping in Agriculture zoning districts to handle such an influx, and;

NOW, THEREFORE BE IT RESOVLED that travel trailer camping will be allowed in Agriculture zoning districts from August 19, 2017 to 5:00 PM on August 22, 2017.

BE IT FURTHER RESOLVED that these temporary travel trailer camping areas shall be exempt from Platte County Subdivision Regulations and development standards, which are laid out in Chapter X of the Platte County Zoning Rules and Regulations.

BE IT FURTHER RESOLVED that the landowner affected may reserve the right to charge a fee for each space rented for travel trailer parking from August 19, 2017 through August 22, 2017.

BE IT FURTHER RESOLVED this Resolution will terminate at 5:00 PM on August 22, 2017.

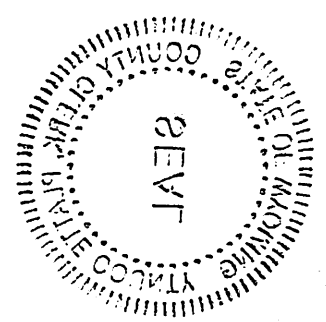
