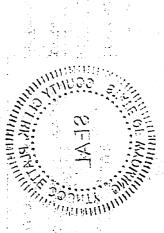

BE IT FURTHERMORE RESOLVED: that the following appropriations be made for the 2018-2019 fiscal year, ending June 30, 2019 and that the expenditures of each officer, department, board or agency be limited to the amount herein appropriated.
