SCHEDULE OF COMMISSIONER MEETINGS FOR THE YEAR 2020

WHEREAS, pursuant to Wyoming State Statute §18-3-502, each Board of County Commissioners are required to meet on the first Tuesday in each month or at such other times as may be designated, and;

WHEREAS, pursuant to Wyoming State Statute §18-3-502, the Platte County Board of Commissioners may reschedule those meetings falling on a holiday or a General Election day by adopted resolution, and;

WHEREAS, the regular meeting of the Platte County Board of Commissioners scheduled for Tuesday, November 3rd, 2020 coincides with the State of Wyoming's General Election, and;

WHEREAS, the Platte County Board of Commissioners desire to encourage all eligible citizens to participate in the election process, and;

WHEREAS, the Platte County Board of Commissioners desire, in the interest of the general health and welfare of the citizens of Platte County, to be able to fully conduct the necessary business of the commission;


NOW, THEREFORE, BE IT RESOLVED, by the Platte County Board of Commissioners of Platte County Wyoming that the regular meeting, which should be held on November 3, 2020, shall be consolidated with the second scheduled meeting in November and held on Tuesday, November 17, 2020.

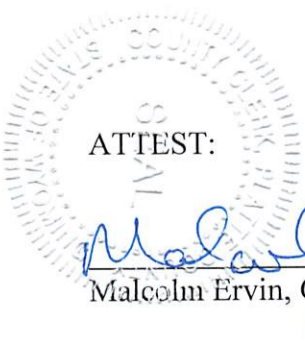
