

PLATTE COUNTY RESOLUTION #2020-03

A RESOLUTION ESTABLISHING A CAP TO THE ABANDONED VEHICLE FUND

WHEREAS, Wyoming State Statute §31-13-111(b) establishes an account known as the county abandoned vehicle account, which is used to satisfy the encumbrance of clearing abandoned vehicles as set forth in W.S.S. §31-13-104, and;

WHEREAS, the Board of County Commissioners set a limit to that account, which shall not exceed one dollar (\$1) for each resident in the county, according to the last Federal Census, pursuant to W.S.S. §31-13-111(b), and;

WHEREAS, Wyoming State Statute §31-13-111(b) says the amount of the abandoned vehicle fund account shall not exceed one dollar (\$1) for each resident in the county, according to the last federal census, and;

WHEREAS, Platte County's population in the 2010 Federal Census was 8,667, and;

WHEREAS, the Board of Platte County Commissioners believe \$8,000.00 is sufficient to carry out the purpose of the abandoned vehicle act.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF PLATTE COUNTY, WYOMING, that the abandoned vehicle account shall not exceed \$8,000.00.

BE IT FURTHER RESOLVED that the County Treasurer shall transfer monies from the abandoned vehicle account to the general fund of the county at any time the balance of the abandoned vehicle account is greater than \$8,000.00, pursuant to W.S.S. §31-13-111(b).



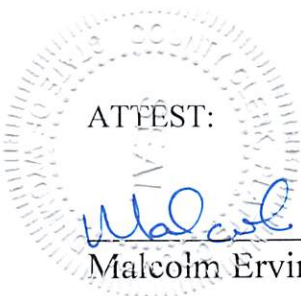
