NOTE: *Pursuant to W.S. § 7-13-105:*

- 1) Individuals convicted within Wyoming or another state may have their right to vote restored, as well as their right to be an elector or juror; and hold any office of honor, trust or profit within Wyoming.
- 2) Individuals convicted in Wyoming only may have their right to knowingly possess any firearm restored.
- 3) Individuals convicted under federal law are NOT eligible for restoration of any rights.

Individuals may have the noted rights restored when the following criteria are met:

- 1) The individual has not been convicted of any felony other than convictions arising out of the same occurrence or related course of events. Same occurrence or related course of events means the same transaction or occurrence or series of events closely related in time or location.
- 2) The felony(ies) must NOT have been VIOLENT as defined by W.S. § 6-1-104(a)(xii)*.
- *VIOLENT Felony includes murder; manslaughter; kidnapping; sexual assault in the first or second degree; robbery; aggravated assault; strangulation of a household member; aircraft hijacking; arson in the first or second degree; aggravated burglary; a violation of W.S. § 6-2-314(a)(i) or 6-2-315(a)(ii), third, or subsequent, domestic battery under W.S. § 6-2-511(a) and (b)(iii); or a violation of W.S. § 6-5-204 (b).
 - 3) The individual completed ALL of the terms of his/her sentence, or in the case of probation, the completion of ALL probation terms and conditions, and in the case of request for Restoration of Remaining Rights, five (5) years have elapsed since the completion of the sentence.
 - 4) This request only needs to be submitted by individuals with convictions outside of Wyoming and those with Wyoming convictions if the requester's sentence was completed on or before July 1, 2023 OR if the requester's sentence was completed on/after that date and the requester hasn't received a restoration of rights certificate after ninety (90) days from discharge.
 - a. The individual's signature indicates the requester certifies the requirements of W.S. § 7-13-105 and its subsections have been met.

Individuals having felony convictions who have NOT received a Restoration of Rights Certificate from the Wyoming Department of Corrections are not legally eligible to enjoy these rights in Wyoming. Please contact the Department of Corrections with any questions.
