BOARD OF PLATTE COUNTY COMMISSIONERS, WYOMING

THE BOARD OF COUNTY COMMISSIONERS, PLATTE COUNTY, WYOMING, met on the 1st day of September 2026 in the county seat of Wheatland. Those present for the meeting were Steve Shockley, Commission Chairman; Ian Jolovich, Commissioner; John “Jeb” Baker, Commissioner; and Malcolm Ervin, County Clerk.

Chairman Shockley called the meeting to order at 9:00 AM. Commissioner Jolovich motioned, seconded by Commissioner Baker, to approve the agenda as presented. The motion carried. Commissioner Baker motioned, seconded by Commissioner Jolovich, to approve the August 20th meeting minutes. The motion carried. Commissioner Baker motioned, seconded by Commissioner Jolovich, to approve the vouchers as presented. The motion carried.

Collections Before the Board: The Board reviewed the daily receipts of Treasurer Kristi Rietz from August 13 through August 26, 2026, which totaled \$1,020,153.09 – of that, approximately \$600,000 were transfers between investment funds and the County general fund.

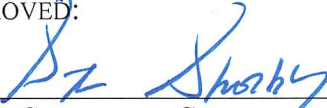
Encroachment Licenses: The Board reviewed, and approved, two encroachment licenses for Range Engineering. The encroachment licenses were alteration to licenses issued to Range Engineering on December 16, 2024. Since issuing the original encroachment licenses, Range Engineering moved their project and requested their encroachments be issued in new locations.

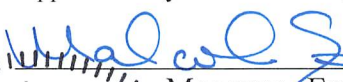
Dispatching Agreement: The Board reviewed an agreement with the Wyoming Military Department (WMD). The agreement requires that Platte County provide dispatching services for the WMD at Camp Guernsey. In return, WMD pays Platte County \$36,000 per year. Commissioner Baker motioned, seconded by Commissioner Jolovich, to approve the dispatching agreement with the Wyoming Military Department. The motion carried.

GIS Mapping Agreement: The Board reviewed an agreement with Oxide Mapping. The agreement provides that Oxide Mapping will provide GIS (Geographic Information Systems) mapping services to Platte County. In the agreement, Oxide Mapping stipulates they will charge \$120.00 per hour, not to exceed \$12,000. The term of the agreement is through June 30, 2027. Commissioner Baker motioned, seconded by Commissioner Jolovich, to approve a GIS agreement with Oxide Mapping. The motion carried.

Courthouse Phase II Renovation: Clerk Ervin presented Change Order #3 for the Courthouse Phase II Renovation. Clerk Ervin reminded the Board of their discussion from the August 20th meeting, in which they prioritized additional work associated with the renovation. The Change Order before the Board was for the purpose of waterproofing the files room, located under the west porch of the Courthouse. The Change Order would increase the project budget by \$34,369.46. Commissioner Jolovich motioned, seconded by Commissioner Baker, to approve Change Order #3 and authorize Clerk Ervin to sign. The motion carried.

There being no further business for board consideration, the meeting adjourned at approximately 9:15 AM. This proceeding was recorded by Clerk Ervin pursuant to Wyoming statute §18-3-402(a)(i)(C).
